• JESG Actions Review

- The Technical Secretary noted the JESG Standing Actions and updates on current actions. The current version of the JESG action log, including any additions from this meeting, is [attached to this Headline Report](#).

• TSOG Update, Fergus Healy and David Bunney, National Grid

- Fergus Healy and David Bunney presented an update to the JESG on the TSOG. Peter Bolitho noted that although there was not a plan to do so yet, the industry would benefit from being consulted with on methodologies that they would be impacted by in the future.
- Garth Graham highlighted that data exchanges had been discussed at a meeting in Brussels the previous week and that this was a real concern for stakeholders. Consideration of the lead times and adjustments to IT systems would be required to be better understood by stakeholders.
- Peter Bolitho suggested that future consultation responses should also be copied to Ofgem. Natasha Zoe Smith confirmed that a summary of these responses would be helpful ahead of going to entso-e and mean that Ofgem are in a better position to influence.
- Stakeholders were provided with a high level overview of the 17 articles that have been identified and asked to send any queries or comments to europencodes.electricity@nationalgrid.com.
- National Grid will ensure that information published on the National Grid website relating to TSOG can be clearly identified by parties.
- Garth Graham confirmed to Vince Hammond that Article 56 and 57 applies to Interconnectors and that this is covered within Article 2.1.f. National Grid agreed to confirm back via the weekly JESG newsletter how this procedure will apply to DSR and Aggregators.

For Article 28, Garth Graham asked for confirmation from National Grid and the Authority if there is a requirement for stakeholders to carry out any action in order to demonstrate compliance. National confirmed that they would confirm this position.

- **TSO Methodology: Regional Design of Long Term Transmission Rights, Sophie Jones, Ofgem**

- Sophie Jones presented an update on regional design of long term transmission rights and confirmed that there would be two hedging products.
- Sophie Jones also confirmed that following that presentation from Michelle Murdoch at the May JESG, stakeholders should provide views to Ofgem by the end of the month.

- **Forward Work Plan Update, Jemma Williams, ELEXON**

- Jemma Williams provided an update on the Forward Work Plan which is being developed by the Code Administrators. Jemma explained that at the latest Code Administrators meeting on 30 May 2017, the Code Administrators had felt the current plan was too detailed and would be difficult to maintain.
