#### 1.0 SUMMARY AND RECOMMENDATION

- 1.1 CAP074 was proposed by National Grid and submitted to the CUSC Amendments Panel for consideration at their meeting on 25<sup>th</sup> June 2004. The Amendments Panel determined that the issue was appropriate to proceed to wider industry consultation by National Grid.
- 1.2 The wider consultation inviting views on CUSC Amendment Proposal CAP074 was concluded on Friday 30<sup>th</sup> July 2004. One respondent, proposed an Alternative to the proposed CAP074 legal text. Under the terms of the CUSC this required a further period of consultation to be undertaken in order to allow the Industry to consider the proposed Consultation Alternative. A further consultation period was considered appropriate following the designation of a GB-wide CUSC and the commencement of BETTA Go Active on 1<sup>st</sup> September 2004. All the correspondence received in response to the Original Consultation, Alternative Consultation and the further consultation post BETTA Go Active are contained in Annexes 3 & 4.
- 1.3 CAP074 proposes to introduce an obligation on National Grid Transco to produce Generation Reconciliation Statements by 30<sup>th</sup> April in each financial year. Currently, National Grid Transco has an obligation to produce these statements by the 31<sup>st</sup> of March. The Consultation Alternative Amendment CAP074 supports the Original Proposal and provides a further tidy up of the cross-referencing within the proposed text.

#### **National Grid Recommendation**

1.4 National Grid recommends the implementation of CAP074 Consultation Alternative Amendment.

#### 2.0 PURPOSE AND SCOPE OF THE REPORT

- 2.1 This Amendment Report has been prepared and issued by National Grid under the rules and procedures specified in the Connection and Use of System Code (CUSC) as designated by the Secretary of State. It addresses issues relating to CAP074 Generation Reconciliation Statements, Date Change and the Consultation Alternative Amendment.
- 2.2 Further to the submission of Amendment Proposal CAP074 (see Annex 1) and the subsequent wider industry consultation that was undertaken by National Grid, this document is addressed and furnished to the Gas and Electricity Markets Authority ("the Authority") in order to assist them in their decision whether to implement Amendment Proposal CAP074.
- 2.3 This document outlines the nature of the CUSC changes that are proposed. It incorporates National Grid's recommendations to the Authority concerning the Amendment. Copies of all representations received in response to the consultation have been also been included and a 'summary' of the representations received is also provided. Copies of each of the responses to the consultation are included as Annex 3 and 4 to this document.

#### 3.0 THE PROPOSED AMENDMENT

#### Background

3.1 CAP074 was proposed by National Grid and submitted to the CUSC Amendments Panel for consideration at their meeting on 25<sup>th</sup> June 2004. The Amendments Panel determined that the issue was appropriate to proceed to wider industry consultation by National Grid.

#### **The Proposed Amendment**

- 3.2 NGC produces Generation Reconciliation Statements in respect of generation related Transmission Network Use of System (TNUoS) Charges to be sent to Users on an annual basis. Previous versions of the CUSC have, in Paragraph 3.12.2 required NGC to produce these by 31<sup>st</sup> March in each financial year. This paragraph was erroneously deleted by CAP065, but its reinstatement is proposed by CAP072. As a consequence of CAP043, NGC is proposing the introduction of a paragraph (to be numbered 3.13.2, following the implementation of CAP055) that would require NGC to produce Generation Reconciliation Statements by 30<sup>th</sup> April of each financial year.
- 3.2 Prior to CAP043, Users annual TNUoS generation liabilities were incurred up to 28<sup>th</sup> February, giving NGC a clear month to calculate reconciliation amounts. One effect of CAP043 was to extend the period in which liabilities could be incurred to 31<sup>st</sup> March of each financial year. Generators with offers for increased TEC can sign these up to the end of the financial year. This significantly reduces the viability of calculating reconciliation charges and in some instances makes it impossible for Users to have received them by 31<sup>st</sup> March. NGC therefore believes that a paragraph should be introduced into the CUSC stating that NGC should produce Generation Reconciliation Statements and send them to Users by 30<sup>th</sup> April in each Financial Year. This would again allow NGC a clear month in which to calculate the reconciliation charges.

#### 4.0 IMPLEMENTATION AND TIMESCALES

4.1 It is proposed that implementation takes place with effect from 10 days after the Authority's decision. NGC also recommends that a decision should be made on CAP074 by early February 2005 otherwise it would not be possible to implement CAP074 in time for provision of the Generation Reconciliation Statements by the end of April 2005.

#### 5.0 IMPACT ON THE CUSC

- 5.1 CAP074 would require amendments to paragraphs 3.13.2 3.13.8 inclusive.
- 5.2 The text required to give effect to the Proposed Amendment is contained as Annex 2(a) of this document. The text required to give effect to the Proposed Consultation Alternative is contained as Annex 2(b) of this document.

#### 6.0 ASSESSMENT AGAINST APPLICABLE CUSC OBJECTIVES

6.1 Introducing this paragraph into the CUSC will enable National Grid to efficiently discharge its obligations under the Act and the Transmission Licence and fulfil its obligations to facilitate competition in the generation and supply of electricity. National Grid supports the Consultation Alternative as the tidying of the cross-referencing within the text is a further improvement.

#### 7.0 IMPACT ON CUSC PARTIES

7.1 The amendment will delay the arrival with Users of their Generation Reconciliation Statements as the deadline for production will change from 31<sup>st</sup> March to 30<sup>th</sup> April of each year.

#### 8.0 IMPACT ON CORE INDUSTRY DOCUMENTS

The Proposed Amendment will have no impact on Core Industry Documents or other industry documentation or require any changes to computer systems established under Core Industry documents.

#### 9.0 ALTERNATIVE AMENDMENT

#### **Description of Alternative Amendment**

9.1 The CAP074 Consultation Alternative Amendment enhances the proposals outlined in the Original Proposal by providing a further tidy up of the cross-referencing within the proposed text.

#### Impact of Alternative Amendment on CUSC

- 9.2 CAP074 Consultation Alternative would require amendments to paragraphs 3.13.2 3.13.8 inclusive.
- 9.3 The text required to give effect to the Proposed Amendment is contained as Annex 2(a) of this document. The text required to give effect to the Proposed Consultation Alternative is contained as Annex 2(b) of this document.

#### **Assessment Against Applicable CUSC Objectives**

9.4 Introducing this paragraph into the CUSC will enable National Grid to more easily and efficiently discharge its obligations under the Act and the Transmission Licence and fulfil its obligations to facilitate competition in the generation and supply of electricity. National Grid supports the Consultation Alternative as the tidying of the cross-referencing within the text is a further improvement.

#### Implementation and Timescales

9.5 As with the original Amendment Proposal, if the Authority should approve implementation of the Alternative Amendment this should take place with effect from 10 days after the Authority's decision. A decision should also be made on the Alternative Amendment by early February 2005 otherwise it would not be possible to implement the Alternative Amendment in time for provision of the Generation Reconciliation Statements by the end of April 2005

#### 12.0 NATIONAL GRID RECOMMENDATION

12.0 National Grid recommends approval of CAP074, Consultation Alternative as it provides all the benefits of the Original Amendment and further improves the clarity of the cross-referencing in the affected paragraphs. Were the Alternative not to be approved we would recommend the approval of the Original Amendment Proposal as this still better facilitates the Applicable CUSC Objectives.

NGC produces Generation Reconciliation Statements in respect of generation related Transmission Network Use of System (TNUoS) Charges to be sent to Users on an annual basis. Previous versions of the CUSC have, in Paragraph 3.12.2 required NGC to produce these by 31<sup>st</sup> March. This paragraph was erroneously deleted by CAP065, but its reinstatement is proposed by CAP072. However, as a consequence of CAP043, NGC is proposing the introduction of a paragraph (to be numbered 3.13.2, following the implementation of CAP055) that would require NGC to produce Generation Reconciliation Statements by 30<sup>th</sup> April.

Description of Issue or Defect that Proposed Amendment seeks to Address (mandatory by proposer):

Prior to CAP043, User's annual TNUoS generation liabilities were incurred up to 28<sup>th</sup> February, giving NGC a clear month to calculate reconciliation amounts. One effect of CAP043 was to extend the period in which liabilities could be incurred to 31<sup>st</sup> March. Generators with offers for increased TEC can sign these right up until the end of the Financial Year. This means that, in some situations, calculating reconciliation charges and sending these to Users by 31<sup>st</sup> March may now prove exceptionally difficult, if not impossible. NGC therefore believes that a paragraph should be introduced into the CUSC stating that NGC should produce Generation Reconciliation Statements and send them to Users by 30<sup>th</sup> April. This would again give a NGC a clear month to calculate reconciliation charges.

Impact on the CUSC (this should be given where possible):

CAP074 is interactive with CAP072. The Authority should therefore consider its decision on CAP072 before CAP074. If CAP072 is rejected, CAP074 will add a new paragraph 3.13.2 to the CUSC with consequential re-numbering of subsequent paragraphs. If CAP072 is approved then only the date in 3.13.2 needs to be changed to implement CAP074. Indicative legal text covering these eventualities is provided.

It is possible to interpret the proposed legal text (reproduced below) as imposing an obligation on NGC to prepare a statement for the 'relevant Financial Year' 'by 30 April in each Financial Year' i.e. by 30 April every year until the end of time for each 'relevant Financial Year'. This interpretation could be eliminated by changing 'by 30 April in each Financial Year' to 'by 30 April in the Financial Year immediately following the relevant Financial Year'. This is assuming that relevant Financial Year is somewhere defined to be the Financial Year for which charges are being reconciled, and not something else.

'3.13.2. As soon as reasonably practicable and in any event by 30 April in the Financial Year immediately following the relevant Financial Year, NGC shall prepare a generation reconciliation statement (the "Generation Reconciliation Statement")in respect of generation related Transmission Network Use of System Charges and send it to the User. Such statement shall specify the Actual Amount and the Notional Amount of generation related Transmission Network Use of System Charges for each month during the relevant Financial Year and, in reasonable detail, the information from which such amounts were derived and the manner in which they were calculated.'
