

### **User Panel Members – Alternate(s)**

# A note to the CUSC Amendments Panel meeting, 25th September 2009

At the meeting of the CUSC Amendments Panel on 31<sup>st</sup> July 2009, National Grid took an action to: "look at the current provisions within the CUSC regarding Alternates at CUSC Panel Meetings and clarify this position" (action 2076).

Please find below a summary of the CUSC provisions relating to alternates, some points worth noting and a number of options relating to these provisions.

#### **CUSC Provisions**

### CUSC 8.6.2 – appointment of alternates

- A Panel Member may appoint an Alternate Member to be alternate for any one panel meeting, by giving notice to the Panel Secretary
- A Panel Member must first choose an Alternate Member not already chosen by another Panel Member
- If there are no Alternate Members left who have not already been chosen, the Panel Member may chose any Alternate Member or Panel Member not already acting as alternate for more than one Panel Member

## CUSC 8.6.4 - notification of alternates

- The Panel Secretary shall promptly notify all Panel Members and CUSC Parties of appointments (or removal) by any Panel Members of alternates and publish on the Company's website
- An alternate may act as alternate for more than one Panel Member

## CUSC 8.6.5 – rights of alternates

- An alternate shall cast one vote for each Panel Member by whom appointed (in addition to own vote where a Panel Member)
- Outlines the rights of an alternate (effectively the same as a Panel Member)

### CUSC 8.9 - quorum

 A quorum shall be six Panel Members who have a vote present in person or by their alternates (at least one of which appointed by the Company)

#### **Points to Note**

- There is no requirement for Panel Members to appoint alternates (Panel members may choose to do so)
- The number of alternate appointments are limited to two per Alternate Member or Panel Member
  - There is no requirement to first appoint a Panel Member not already appointed as another member's alternate (once all Alternate Members have been appointed). Should this be best practice?



- There is no explicit statement of whether an alternate must represent their view or the views of the Panel Member
  - Normal practice has been for the alternate to obtain the Panel Member views, then make their own mind up based on the panel meeting discussion
  - o Does this need to be explicitly stated?
- Notification of alternates to be given to the Panel Secretary
  - Current practice is to request this in writing, should this be specified in the CUSC?
- Notification of alternates to be given to the CUSC Panel and CUSC Parties by the Panel Secretary
  - o Currently only detailed following the panel meeting
  - o Should this be done prior to the panel meeting?
  - If so, when should this be done? (as notification can be received at different times)
- Panel Meeting referenced in 8.6.2 (c) in relation to alternates is not a defined term

### **Options**

- Leave CUSC provisions as currently
- Prepare a best practice note for the interpretation of the CUSC provisions
- Consider requirement for an Amendment Proposal via the Governance Standing Group
- Discuss requirements for an Amendment Proposal at future Panel meeting, with National Grid to progress
