Meeting Name: CUSC Modifications Panel Meeting

This note sets out the headlines and key decisions of the most recent meeting of the CUSC Modifications Panel under the CUSC constitution. Full minutes of the meeting will be produced and approved at the next meeting of the Panel and will then be published on the website.

1) Minutes of Previous Meeting

The minutes of the CUSC Panel meeting held on 25 May 2012 were APPROVED and will be published on the National Grid website shortly.

2) New CUSC Modification Proposals

CMP211 - Alignment of CUSC compensation arrangements for across different interruption types. This Proposal was raised by National Grid and seeks to align the compensation arrangements for loss of transmission access. The Panel agreed that CMP211 should be progressed as Self-governance and for it to progress to a Workgroup and report back to the CUSC Panel in October 2012.

CMP212 - Setting limits for claim: submission, validation and minimum financial threshold values in relation to Relevant Interruptions. This Proposal was also raised by National Grid. CMP212 seeks to adjust the administrative arrangements with regard to dealing with claims for loss of access. CMP212 proposes changes to Section 5.10 of the CUSC. The Panel agreed that CMP212 should be progressed as Self-governance and for it progress to a Workgroup and report back to the Panel in October 2012.

CMP213 – Project Transmit TNUoS Developments. CMP213 was raised by National Grid following the Authority's direction as a result of the Significant Code Review on the electricity transmission charging arrangements². The Panel agreed for CMP213 to progress to a Workgroup and to report back to the Panel in December 2012. The Panel agreed that CMP213 does not meet the Self-governance criteria.

CMP202: (Revised treatment of BSUoS charges for lead parties of Interconnector BM Units). The Panel voted unanimously that CMP202 better facilitates the Applicable CUSC Objectives and so should be implemented.

Barbara Vest has resigned from her post as CUSC Panel Member due to other work commitments. The mid-term election process that commenced following the resignation of Fiona Navesey as CUSC Panel Member has been extended to take account of this further resignation.
