This note sets out the headlines and key decisions of the most recent meeting of the CUSC Modifications Panel under the CUSC constitution. Full minutes of the meeting will be produced and approved at the next meeting of the Panel and will then be published on the website.

## 1) Minutes of Previous Meeting

The minutes from the meeting held on 20 December 2013 were approved subject to changes and are available on the National Grid website.

## 2) New CUSC Modification Proposals

**CMFTP226 – ‘Amendment to BSUoS Methodology to reflect changes to the Transmission Licence’.** The CUSC Panel determined that this should be progressed through the Fast Track process and should be implemented. CMFTP226 is intended to be published on 4 February 2014 for a 15 working day objection window. If no objection is received, the Code Administrator will aim to implement CMFTP226 on 12 March 2014.

## 3) Workgroup Updates

**CMP222 – User Commitment for Non-Generation Users.** The Panel noted that the Workgroup Consultation closed on 20 January 2014 and received 4 responses. The post-Workgroup Consultation meeting will take place on 6 February 2014 and the Workgroup is due to report back to the CUSC Panel on 28 February 2014.

**CMP223 – Arrangements for Relevant Distributed Generators under the Enduring Generation User Commitment.** The Panel noted that the CMP223 Workgroup Consultation had been published on 17 January 2014 and will close for comment on 14 February 2014. The Workgroup is due to report back to the CUSC Panel on 28 March 2014.

**CMP224 – Cap on the Total TNUoS Target Revenue to be recovered from Generation Users.** The Panel noted that the Workgroup Consultation had closed for comment on 23 January 2014 and received 9 responses and 1 CUSC Workgroup Consultation Alternative Request. The Workgroup met on 30 January and put forward the Original and 3 Workgroup Alternate CUSC Modifications. The Workgroup vote was held and the Workgroup Report is due to be presented to the CUSC Panel on 28 February 2014.

The Panel noted that the Authority approved CMP221 'Interruption compensation in the absence of Market suspension during a Partial Shutdown' and have directed that it should be implemented on 31 March 2014.
