### Key areas of discussion

- The original intention of the meeting was to hold the Alternative Vote on the four Alternative Requests raised at the previous meeting. However shortly before the meeting was due to start, a further 24 additional Alternative Requests were shared.
- The Chair recognised that procedurally, Alternative Requests may be raised at any time up until the Workgroup Vote, however shared feedback that given the time constraints of these modifications, early sight of Alternatives would make the best use of Workgroup member's time.
- A Workgroup member shared their intention to raise a further alternative, which builds off Alternative 1.
- To give Workgroup members time to consider the additional Alternatives, the Chair amended the timeline for the modification, which can be found in the next steps section below.
