

STC Panel Headline Report – 25 May 2022

Approval of April 2022 Minutes

Panel Members approved the minutes from the April 2022 Panel meeting which can be found on the National Grid ESO website via the following link.

New STC/STCP Modifications

One new modification had been formally submitted for the May Panel:

PM0125: Amendment to Allow Electronic Switching Instruction

This is a consequential modification that seeks to allow minor changes to STCP01-01 as required to allow instruction 'by another agreed method' in the situations where a verbal instruction is currently considered appropriate.

Before giving their vote, some Panel members expressed concerns around the implementation of this proposal. This had to do with how MRPL/Peakgen acts on instruction and whether this is within their safety rules. Panel requested further details on this so it was suggested that there would be an action.

Panel agreed to approve the STCP changes, for it to be implemented on 1 June 2022.

Draft Final Self-Governance Modification Report

Two reports had been submitted for the May Panel

CM081- STC change to remove Gender Specific References or Terminology



The Panel determined with unanimous agreement that the modification should be implemented on 1 July 2022.

The Final Self - Governance Modification Report will be published on 6 June 2022. The appeals window will open from 6 June 2022 until 5pm 24 June 2022. If no appeals are received, the modification will be implemented on 1 July 2022.

Draft Final Modification Report

CM078- STC change to reflect CUSC modification CMP328 relating to Transmission Connections that trigger an impact assessment on the distribution network

The Panel determined that the proposer's solution should be implemented if required by the Authority's decision on CMP328

The Final Modification Report will be submitted to the Authority on 6 June 2022.

Withdrawal of Modification

CM082- STC Governance Improvements

At the April Panel, Panel agreed that this modification should be split up and re-proposed as 2 new distinct modification proposals.

At the May Panel, it was agreed that this modification should be formally withdrawn, the Proposer will present 2 new modifications to Panel in June.

The Chair shared the new timeline for CM079 and advised Panel that an updated timeline will be re-presented to Panel in July.

The Chair also shared an update on the Code Administrator Annual Report, that it has been published and can be found on the website
