

## Headline Report – 25 August 2022

### Grid Code Review Panel

The Grid Code Review Panel Headline Report is produced after every Panel and aims to provide an overview of the key decisions made. Minutes for this meeting will be published separately.

### Approval of Panel Minutes

The meeting minutes from the Panel on 28 July 2022 were approved subject to minor comments from the Panel being incorporated and these will be uploaded to our website.

### New Modifications

The following new Modification Proposal was presented to the Panel:

#### **GC0158 ‘Reversing unimplemented aspects of GC0068’**

This modification aims to fully reverse the unimplemented changes to the Grid Code which formed part of the approved modification ‘GC0068: Grid Code New and Revised Unit Data and Instructions’. It is a tidying up exercise and replaces the withdrawn modification proposal GC0126.

The Panel by majority agreed that GC0158 should follow the Self Governance route and proceed to Code Administrator Consultation.

#### **Decisions since last Grid Code Review Panel**

There are no Ofgem decisions on Grid Code Modifications since the last Grid Code Review Panel.

Modification	What this seeks to achieve	Expected Decision Date
GC0141	<i>The Government (BEIS) and the Regulator (Ofgem) investigated and reviewed the incident on 9th August 2019 when some 1 million customers lost their electricity supply as a consequence of unexpected losses of Generation following a correctly cleared fault event on the Transmission System.</i>	Early October 2022

### Draft Self Governance Final Modification Reports

The following Draft Self Governance Final Modification Report was presented to the Panel:

#### **GC0157 'Grid Code Housekeeping Modification'**

This Proposal seeks to make minor corrections in the Grid Code of errors identified from previous implementations. It also presents for information only an amended housekeeping process that will be used by the ESO going forward.

The Panel unanimously determined that the Proposer's solution should be implemented, the 15 working days appeal window will be opened on 07 September 2022 until 5pm on 28 September 2022, to be implemented on 06 October 2022.
