# Key areas of discussion

The Workgroup discussions are summarised according to agenda items:

# Approach and Update on Urgency Status

- Ofgem recommended that both the <u>BSC P448 modification</u> and the Grid Code GC0160 modification were granted urgency on Friday 30 September and agreed the urgent timelines.
- Both will be progressed by a joint workgroup with a plan that both Final Modification Reports will be submitted by Tuesday 22 November. There will be slight differences in the timeline to accommodate differences in the modification governance process.

#### Proposers' presentation

- BSC P448: The Proposer presented to the Workgroup the reason for change within the BSC (see slides and BSC summary for detail)
- Grid Code GC0160: The Proposer advised that GC0160 is a consequential modification to the
   <u>BSC P448 modification</u>, and has been raised ahead of the final solution in anticipation that there
   will be a change in status/definition of a Physical Notification (PN), if throughout Workgroup
   discussion and Workgroup Consultation it is concluded that no change is required the Proposer
   will move to withdraw the modification.
- The Proposer ran through the proposed Grid Code solution (see <u>slides</u> for detail). During discussion a Workgroup Member queried if there is other data available to support the actions taken, why a change to the definition of the PN is needed? The Proposer explained that the PN would reflect what the affected generator would have notified had the gas not been interrupted. If the PN is set to zero, the imbalance/credit risk would not be mitigated in the short term. And that any other way would require a whole system change which given this Winters work/capacity was considered to be difficult to implement.



#### Review of Terms of Reference

- BSC P448: Specific Terms of Reference, after initial queries were raised around the requests from the BSC Panel, it was confirmed that Panel's queries had been captured but any further nuances would be covered towards the end of the Workgroup process.
- Grid Code GC0160: The Terms of Reference were presented to the Workgroup for agreement, including the standard Terms of Reference what in addition the elements of the modification need to be considered. The ask was put on those within the group if any of the Grid Code members had any comments, however no comments or amends were raised.

# P448 solution and legal text – impacts on GC0160

- Other than the query on the justification for changing the PN definition in the Grid Code, there
  were no other areas of the P448 proposed legal text highlighted any impacts on GC0160 within
  the meeting.
- The remaining P448 proposed legal text will be covered off in the next meeting

# **Next Steps**

 The second joint workgroup meeting will take place on 5 October to ask specifics to the GSO and define the BSC solution to understand the requirement for GC0160.
