The aim of this Modification is to outline the work that needs to be completed within GB to ensure compliance with NCER and address some other related items which neatly fit within the Emergency and Restoration Code arena. Draft Final Modification Reports

The following Draft Final Self Governance Modification Report was presented to the Panel:

GC0158 'Reversing unimplemented aspects of GC0068'

This modification aims to fully reverse the unimplemented changes to the Grid Code which formed part of the approved modification 'GC0068: Grid Code New and Revised Unit Data and Instructions'. It is a tidying up exercise and replaces the withdrawn modification proposal GC0126.

The Panel, by a majority of 5 votes to 4 votes, determined that the Proposer's solution should be implemented. The Final Self Governance Modification will be published on 9 November 2022, the appeals window will then close on 29 November 2022 ahead of the planned implementation date of 06 December 2022.
