Key areas of discussion

Action Log Review

The Workgroup didn't review any actions as the primary focus was to work through the outstanding draft legal text.

Workgroup discussion and review of Legal Text

The Workgroup reviewed the Legal Text live; highlights were:

- Workgroup agreed with the proposed definition for Adoption Agreement and Contestable Asset within CUSC Section 11.
- ESO Rep advised Workgroup that the suggested changes to Exhibit B have been incorporated.
- The CUSC Section 2 draft legal text was updated live on the screen (the numbering changed during the Workgroup meeting).
 - 2.23.1 – Agreed to keep “and the ongoing maintenance of those assets” and add clarity to the text with “where not transferred via an Adoption Agreement”
 - 2.23.2 – Agreed to remove clause
 - 2.23.3 – Agreed to remove the purposed changes
 - 2.23.4 – Added “subject to the provisions in 2.23.4.” to the last paragraph
 - 2.23.5 – Added an extra point to cover system security. Removed the last paragraph of e).
 - 2.23.6 - Created a new clause from 2.23.5 last two paragraphs, added “dispute provisions”.
 - 2.23.7 – The Workgroup considered removing the requirements section of this clause as it was seen as a repetition of 2.23.5. RW to clarify with Neil Bennet the Legal Text comments he made around this clause. Workgroup agreed that a piece around Contestable – TO prevention is required, further discussion needed. 2.24.1 – Changed the word “will” to “may”.
 - 2.24.2 - Created a new clause from 2.24.1 last paragraph.

AOB & Next Steps

The Chair summarised next steps as follows:

- The meeting ended ahead of discussing clauses 2.24.3, which pending discussions with the Proposer will be added to a future Workgroup meeting
- Share draft legal text with Workgroup members.
