What is the issue?

An STC(P) modification is required to reflect changes to data requirements, templates, and processes as a consequence of CUSC modifications CMP315 & CMP375. Also, to incorporate 'Lessons Learned' from the RIIO-2 Expansion Constant EC & Expansion Factors EF re-calculation.

Why change?

The Expansion Constant (EC) influences the locational signal in the calculation of TNUoS charges and is recalculated for the start of each onshore TO price control. The EC and Expansion Factor (EF) currently used within the calculation of TNUoS tariffs look at a limited scope of development to the NETS. As the nature of NETS development and investment has changed over time, the number of projects eligible for consideration within calculation of the EC and EFs have shrunk.

CMP315 and CMP375 may create a new methodology for calculating the EC and EF and therefore this STC(P) proposal is required to update the data provided by TOs to be reflective of this methodology and to incorporate 'Lessons Learned' from the RIIO-2 Expansion Constant EC & Expansion Factors EF re-calculation.

What is the proposer's solution?

The Proposers solution is to incorporate the required changes resulting from CMP315 and CMP375 and Lessons Learned from the RIIO-2 EC & EF re-calculation.
