Discussion and Questions

Introduction done by everyone due to some new people on the call.

1. SME slot - Balancing costs

February balancing costs: Filippos Panagiotopoulos talked through drivers of the month's balancing costs. Jill gave an update to last months question "Is there a threshold at which wind become a problem" – resulting in a conversation around this with Adam and the below question, response and take away action. Plus questions at the end of the session.

Question	ESO response	
Adam – (Regarding Wind section) Is there a rough rule of thumb at what level of wind does it become a problem? Sounds like there is one but no one wants to give that number? When	Jill/Lizzie – Completely depends on factors during each day as each day is different. This means the threshold changes each day making it hard to put a threshold number on it.	
does it start costing you money?	Action: Provide more information whether that takes the form of a case study of certain days showing a timeline	
Anything you can provide to help explain high costs days more than saying 'there was a lot of wind' would be helpful	of decisions made during that day or look at the history of the whole threshold over the past year. Set up a session on it after BP1 to discuss more in depth.	
Adam – When will the Minor Components issue be fixed? Do you have an update?	Filippos – Will have some time to look at this with the IBM soon. Need to be sure that changes in the script don't destroy the database.	
Adam – Will minor components issue be fixed going in to BP2?	Filippos – I will soon have time to look for a solution	



Adam - There was a manifest error that you were going to be looking into to provide more detail on, did you get anywhere with that?	Filippos – This is now flagged in our system.
Would it be possible to get a bit of a just a brief write up on exactly what happened and what drove that and what the outcome was?	Action: Filippos to provide a brief write up on what exactly happened with the manifest error, its driver and what the outcome was
James – What's the reason for the lower winter contingency cost in February compared to January?	Filippos/Jill – These are estimates and are subject to change. We're spreading the cost across the whole of the winter rather than just dumping it all on to the end of March.
For March, would we expect cost to be on a daily basis, the same as February or would it be revised from March, do you know?	Filippos – Unsure on this.
How does this revision in costs affect the forecast?	Filippos – Next month we have the measurements and run the forecast model in the first 2 weeks

Lizzie introduced herself as the new balancing costs manger. Gave an overview of the plan for the next 12 months. Would like Ofgem's input into the strategy for balancing costs for the next 12 months. Suggesting getting together at Wokingham or a virtual call first. Adam agreed it would be beneficial. Action: Lizzie and Adam to go away and provide best dates/times to have a call first. Also figure out exactly what we want to cover, who needs to attend and what it's going to look like.
