Key areas of discussion

Objective

The aim of Workgroup 2 was to consider what additional analysis is required to move forward with the Proposal.

ESO data presentation

The Proposer had requested analysis from ESO in Workgroup 1. This was presented to the Workgroup by the ESO Representative (AP). The presentation examined Battery and Pump storage data across GB in 2022.

The analysis in the presentation covered Self Dispatch Behaviour, Bid Acceptance Data and Bid Pricing Data. It was made clear by the AP that ESO understood limitations and constraints surrounding the data analysis and welcomed suggestions from Workgroup members for more targeted data requests.

DJ expressed concern about the amount of knowledge and available data ESO has with regards to storage capabilities and made an insight request to ESO. He suggested that if ESO did have better visibility how would this affect their behaviour.

The Proposer (DC) confirmed he would continue to see external consultancy support prior to the next Workgroup. It was indicated that what has happened in the past may not necessarily reflect what will happen in the future.
