Key areas of discussion

The aim of Workgroup 5 was to discuss and develop the solution.

Action Review

The Chair reviewed the actions with the Workgroup and updated the status accordingly.

One Workgroup member requested to extend action 8 to investigate current user commission process, delivery of works and compliance processes. The member felt CATOs should follow the same policy and procedures as TOs and not treated as a glorified user. Workgroup members agreed the process should not be over prescriptive and agreed to widen the scope of the action.

Timeline Review

The Workgroup agreed to the updated timeline presented by the Chair.

Developing the solution

The Proposer walked the Workgroup through each stage of the proposed Grid Interface Process which would be written into an STCP.

A Workgroup member noted that the timescale could cover multiple years. The Proposer agreed and explained how multiple feedback loops would be required in the process to revert to previous stages.

The Proposer, ESO SME and a Workgroup member discussed the user connection application process. It was confirmed by both the Proposer and the ESO SME that this would be part of the tender process and TOs would be fundamental in the decision making. It was confirmed by the Proposer that it would not be codified.

One Workgroup member felt there was a potential WACM with a less prescriptive process and offered to collaborate with other Workgroup members to consider an alternative.

The Workgroup agreed an additional circuit breaker is not required. The Proposer stated ownership boundaries and access must be clear if a circuit breaker is not required and agreed to investigate boundaries and assets in the interface agreement in schedule 15. A Workgroup member suggested the best interface solution may be found in the SQSS.
