

Headline Report – 26 July 2023

System Operator Transmission Owner Code (STC) Panel

The STC Panel Headline Report is produced after every Panel and aims to provide an overview of the key decisions made. Minutes for this meeting will be published separately.

Approval of Panel Minutes

The meeting minutes from the Panel on 28 June 2023 were approved and these have been uploaded to our website.

New Modifications

The following new Modification Proposal was presented to the Panel:

PM0135 ‘STCP19-13 Proposed changes to STCP19-3 to improve clarity and Compliance responsibilities between the ESO and TOs’

This proposal seeks to make changes to STCP (System Operator/Transmission Owner Code Procedure) 19-3. The aim of the proposed changes is to standardise ways of working and improve the clarity around Compliance responsibilities between the ESO and TOs..

A few Panel members raised concerns the proposal might remove obligation/involvement from the ESO and that the definition of type B, C and D Power Station would need to be defined clearly.

Panel's suggestion was for the Proposer to arrange a meeting with TO representatives to discuss any material impacts and share details with Ofgem for approval.

CM092 ‘Schedule 9: TO Construction Terms Update’

This Proposal seeks to reflect the existing position under the contracts in practice and/or to reflect the perceived intent behind certain terms and/or to reflect the position under the NGENO Construction Agreements to confirm flow-through / mirroring of terms.

After a discussion with Panel, it was agreed that the Proposer would arrange a meeting with ESO Legal team to alleviate any concerns there might be around point four of the Proposal.

The Proposer will return to August Panel when a clear solution has been defined.

Awaiting Decisions

Modification	What this seeks to achieve	Expected Decision Date
CM080	Process for aggregated assessment of Distributed Generators that impact (or may impact) on the National Electricity Transmission System.	Expected decision date of this and related CUSC Modification (CMP298) is 21 August 2023.
