1. Introductions and Apologies

2. Minutes

4. Authority Decisions and Updates

GS shared that the Frequency Risk and Control Report (FRCR) decision is being drafted with expected publication towards the end of May 2023.

5. In Flight Modifications Updates

GSR029: Review of Demand Connection Criteria to Align with EREC P2/7

The GSR029 workgroup updated the Terms of Reference to amend a typographical error. Panel approved amendment of the Terms of Reference to correct the typo.

GSR031: Introducing Competitively Appointed Transmission Owners

Panel approved amended timeline with one Panel member noting that this may be subject to change.

GSR032: Implementation of the Electricity System Restoration Standard

Following workgroup discussion an additional Terms of Reference has been added. Panel approved additional point within the Terms of Reference.

6. Review of SQSS current and future modifications

CL presented a Review of SQSS current and future modifications.

RW shared SHET are getting increasing numbers of applications for electricizers and concerned with the loss of outfeed risk and asked if was covered in section 2. CL confirmed that it was being covered in section 2, but if significant risk we could look at bringing this forward and covering this issue quicker. BA shared the view of a requirement to establish an acceptable level of outfeed loss risk. RW also shared that currently in discussions with the ESO to understand customer choice criteria and what level applications need to split their application into.
