New Modifications

New / Pending Authority Decisions

Decisions since the last Panel

Modification	What this seeks to achieve	Decision
GC0161	The modification aims through minor alterations to OC6 to allow sites to be protected in the event of an operational situation where there is a need to reduce National Demand.	Approved on 15 September 2023 and will be implemented on 02 October 2023

Awaiting Decisions

Modification	What this seeks to achieve	Expected Decision Date
GC0156	In October 2021, BEIS issued a direction in accordance with Special Condition 2.2 of National Grid’s Electricity System Operator’s Transmission Licence implementing an Electricity System Restoration Standard (ESRS) which requires 60% of electricity demand to be restored within 24 hours in all regions and 100% of electricity demand to be restored within 5 days nationally. The ESO is proposing a number of changes to the Grid Code to facilitate this.	31 October 2023

Workgroup Reports

The following Workgroup Report was presented to the Panel:

GC0154: Incorporation of interconnector ramping requirements into the Grid Code as per SOGL Article 119

This modification aims to incorporate interconnector ramping arrangements into the Grid Code to allow clarity for stakeholders.

The Panel agreed that the Terms of Reference have been met and agreed for GC0154 to proceed to Code Administrator Consultation, however asked for the Workgroup to consider some suggested legal text alterations. Following this, the Code Administrator Consultation will be published and will close after one calendar month.
