Key areas of discussion

Introductions and Code Process Overview

The Chair welcomed the group and introductions were completed. The Chair outlined the Code Modification Process, clarified the Workgroup membership and Workgroup voting rules.

Objectives and Timelines

The Panel-agreed timelines were shared and agreed.

Terms of Reference

The Panel-agreed terms of reference specific to this modification were shared and agreed.

Proposer presentation and form template

The background and rationale for the modification were shared with the group. The Proposer highlighted the scope for this modification and noted that the Workgroup consider this an initial LOA (Letter of Agreement), with further developments in this area to be considered in subsequent modifications being planned (it's suggested the Workgroup Report notes the recommendations of the Connection Action Plan to explain this).

Workgroup discussions covered several points of principle about the LOA and reviewed the draft template shared by the Proposer and suggestions from the Workgroup submitted to date. Topics discussed were:

- Legal status of the LOA, additional validation checks by ESO and LOA's relationship to M3 milestone
 obligations and queue management
- Inclusion of a site plan with LOA (not including cabling routes for consistency with M3 milestone)
- Guidance on minimum acreage for different technology types (to feature in the Workgroup Report/guidance note, not codified within the CUSC)
- Clarity LOAs on projects involving multiple landowners, challenges from other developers, and the
 relevance of a landowner withdrawing agreement
- Wording of the draft LOA, standardisation of the LOA and the need for disclaimers to avoid obligations on landowners
- Suggestions to review distribution LOA examples for guidance on a transmission LOA
- Whether the LOA should be a standard template or allow variations
