## **Key areas of discussion**

The Chair welcomed the Workgroup and shared the meeting agenda, highlighting the key areas of discussion.

Due to members availability and quoracy reasons the meeting will be shorter than initial planned, therefore the Workgroup agreed to focus on the legal text review.

### **Legal Text Review**

- **OC2.1.4** The Proposer agreed to the suggested comments but will need to speak to the Code Governance team about the formatting issues.
- **OC2.16** A Workgroup member questioned the use of the word "output". The Workgroup member will provide an alternative wording.
- OC2.2 Agreed to delete.
- OC2.3.2.1 Discussion around point a) on the "Settlement Period or longer and up to three years ahead". A Workgroup member suggested that point b) needs to have the "up to three years ahead" but point a) should not include it. The Proposer will seek clarification and revert to the Workgroup.
- OC2.3.1.2.2 Housekeeping modification to be raised to define the terms in EU Transparency Regulations that might be required. A Workgroup member suggested to do it as part of GC0164 as this only occurs in OC2, the Proposer will check with legal and revert to the Workgroup.
- OC2.3.1.2.3 Suggestion to number each paragraph as they refer to different groups. The Proposer agreed.
- OC2.3.1.2.4 ii Proposed new terms for "National Surplus" and "National margin" A Workgroup member shared concerns about the need to align with BSC. Workgroup members advised that is not clear and that it should be reverted to the original text. The Proposer will consider and revert to the Workgroup.
