Key areas of discussion

The Chair welcomed Workgroup members and talked through the agenda.

Action Review

Action 5 – Proposed to close. The Proposer advised that there is no observed difference between Demand at peak across the winter 2023 compared to other winters.

Action 6 and 13 – Proposed to close. The Proposer confirmed that they had met with the Authority, who confirmed they don't have any further analysis as part of DCP414 other than what was already provided.

Action 9 – Proposed to close. The Proposer confirmed they had met with the Authority to discuss legal text. Updates will be given to the Workgroup in the legal text review later in the meeting.

Workgroup Consultation Responses Review

The Chair shared the summary of the Workgroup Consultation responses for both CMP430 and CMP431 with the Workgroup. Both Workgroup Consultations were issued on the 17th of April 2024 and closed on the 24th of April 2024. CMP430 Workgroup Consultation received 5 non-confidential responses and CMP431 Workgroup Consultation received 1 non- confidential response.

The Proposer stated that a few questions were raised as part of the Workgroup Consultation in order to help get data to help with the development of the modification and the ToR, but no further insights into the number of sites impacted had been provided in the responses. The Proposer asked the Workgroup members to provide any additional thoughts or comments they might have on the Workgroup Consultation, by the next Workgroup meeting.

The Workgroup had no comments.

Legal Text Update

The Proposer shared an update on the legal text with the Workgroup. The Proposer explained the new approach that will be taken for the legal text for CMP430 (CUSC Section 14).

ESO

The Proposer advised that following previous feedback that suggested that we could not introduce new terms and definitions to CUSC that had not been approved – i.e., that are contingent on draft BSC text yet to be approved (Measurement Class(MC), Connection Type Indicator (CTI), Domestic Premises Indicator (DPI) in Section 11 and, Section 14 was too complicated and confusing. The ESO had developed 3 new approaches for legal text based on feedback:

- •New Approach 1 Describing changes to Charging, Non-Charging and BSC arrangements.
- •New Approach 2 Describing charging Arrangements without newly defined terms.
- •New Approach 3 Describing changes to Charging and Non-Charging Arrangements

The Proposer advised that the ESO met with Ofgem and ESO Legal team last week to go through approaches before bringing these to the Workgroup.

- •New Approach 1 was discounted as not viable and resulted in the same concerns seen previously and would likely lead to "send back".
- New Approach 2 could work but has not been subject to legal review yet, will not be shared with the Workgroup until then.
- •New Approach 3 has been subject to ESO Legal review and is the preferred approach but potentially needs refining (less is more).

The Proposer explained that the Principles for New Approach 3 are based on explaining to CUSC Parties what changes as a result of transitioning to the MHHS arrangements – Annex 4 from the Consultation. This proposes to introduce a new section to CUSC Section 14 and clarifies the change in charging arrangements for affected MPANs. The Proposer advised that whilst we cannot introduce a table, we are able to add a guidance note to CUSC.

Regarding CMP431 (CUSC Non-Charging) suggested legal text, the Proposer highlighted the following:

- · Minimal definitions required under this approach.
- Domestic Premises could be defined using reference to the BSC or Supply Licence.
- If it is established no changes required to Section 3 or Section 11 of CUSC, CMP431 could be withdrawn.

The Proposer went on to share the Draft Legal Text for CMP430 (CUSC Section 14) with the Workgroup advising that the clause 14.17.41.2 is about stating that all charging arrangements will remain the same except for the specific scenarios described in the two bullet points within the clause.

A Workgroup member commented on the issues with the concept of reverse migration, suggesting that a concept of MHHS MPANS and Non MHHS MPANS could be incorporated, advising that in this way it won't matter whether they haven't been migrated at all or reversed migrated, they should just be treated the same. The Proposer will take this suggestion away and revert to the Workgroup.

Next Steps

- The Workgroup agreed to cancel the Workgroup meeting on the 3rd of May in order to allow time for the Proposer to develop the legal text further.
- Next Workgroup meeting is on the 8th May 2024.
- The Chair will circulate the relevant materials ahead of the next Workgroup meeting and cancel the meeting planned for the 3rd of May.
