- 6625. The Chair advised the Panel that this meeting was for **CM094 Amendment to Bi- Annual estimate provisions** Workgroup Report and invited Milly Lewis (ML) to take forward.
- 6626. ML summarised that this modification proposal seeks to accelerate the connection of viable customer connections, allowing TOs, not to pass on costs associated with strategic transmission reinforcements that have received regulatory approval. **CM094** documentation can be found here.
