## 1. Introductions and Apologies

- 12436. Apologies for absence were received from Catia Gomes, Joe Colebrook, Kyran Hanks, Paul Jones and Rashmi Radhakrishnan.
- 12437. No declarations of interest were recorded.

#### 2. Minutes from previous meetings

12438. The meeting minutes from the CUSC Panel held on 31 May were approved.

#### 3. Review of actions log

12439. Action 182 - CG confirmed that this action is ongoing and to remain open. The Panel agreed with this.

## 4. Chair's update

12440. There were no updates from the Chair.

# 5. Authority Decisions

12441. NH confirmed that no decision updates would be published until after the general election on 04 July 2024 and there was an expectation that all expected decision dates would be reset following this period.

#### 6. New modifications

12442. TM informed Panel Members that one new CUSC Modification was being presented to the Panel to agree the governance route.

#### CMP438: Clarification of Illustrative Example of a TNUoS Demand Reconciliation

- 12443. NG from the ESO delivered a presentation on CMP438.
- 12444. Panel members questioned the extent of the legal text changes proposed.
- 12445. JD and HH highlighted that the number of changes to the legal text suggested that the proposal is going further than a normal housekeeping modification and therefore a more material change.
- 12446. The Proposer explained that it was mostly changes to the summary data and was therefore not material.
- 12447. JD believed that readers must be taken through the changes to be able understand the extent and that this needs to be conveyed in the Code Administrator consultation.
- 12448. The Proposer agreed to clarify the extent and share the outcome with JD prior to Code Administrator submission.
- 12449. All Panel members agreed this modification had a clearly defined defect and scope.
- 12450. Panel members unanimously agreed that this modification should follow the Self-Governance route and that the modification should proceed to Code Administrator Consultation.

## 7. In flight modification updates

- 12451. MV gave an update to Panel members regarding the urgent connection modifications (CMP434/CMP435) explaining how the Urgency timelines previously agreed by the Authority been ambitious. MV noted there had been much industry engagement to progress the modifications but there were still key topics requiring exploration. MV sought the Panel's advice on how best to manage the workgroup process to achieve a robust outcome within the critical timeline.
- 12452. Panel members were broadly supportive of the approach being taken by the ESO regarding the timeline assessment but raised a number of concerns. Members encouraged the ESO to rank the remaining topics in importance and risk ahead of the solutions being finalised to ensure that time was being spent efficiently. The Panel encouraged the ESO to be clear on the preferred solution and not need to feel a consensus was required to progress.
- 12453. A Panel member also highlighted a risk of future legal disputes if the process does not allow enough time for robust review and challenge at each stage ahead of being implemented, i.e., Industry consultation, Panel recommendation and Authority decision.
- 12454. GG, as a Workgroup member of the urgent connections modifications, requested the ESO to consider budgeting time for stakeholders to read and review the consultation and advised the Workgroup to focus on one subject at a time, rather than multiple areas. GG felt in person meetings in for the Urgent connections modifications would be valuable to the progression of the modifications.
- 12455. HH asked for the ESO to only present a clear minimum viable product for the urgent connection modifications, to ensure that OFGEM can undertake a full opinion and therefore able to make a decision.
- 12456. MV recognised the need to balance the urgency of the modifications and the robustness of developing the solution and therefore requested further time to have discussions with Workgroup members, Ofgem and DESNZ to put forward a revised timeline recommendation. Panel members agreed.
- 12457. MV thanked the Panel for its helpful input and agreed to provide a timeline update on CMP434/CMP435 at a Special CUSC Panel planned for 12 July 2024.
- 12458. CG and ML talked the Panel through, in detail, the progression of the other in-flight modifications and informed members that the Workgroup Reports for the other urgent modifications, CMP430/CMP431, will be presented at the July Panel.
- 12459. The Panel agreed to continue the modification workgroup meeting hiatus, noting that work was continuing for all modifications and that this hiatus would be subject to further Panel review on a monthly basis.

#### CMP424: Amendments to Scaling Factors used for Year Round TNUoS Charges

12463. The Panel unanimously agreed that the Original proposal better facilitates the appropriate CUSC objectives than the Baseline and should be implemented. The Final Modification Report will be issued to Ofgem on 09 July 2024.

#### 10. Discussion on Prioritisation

- 12464. As part of the prioritisation discussion, HH presented an Authority view on prioritisation, applying the following criteria: Is the modification related to a strategic project? Are there interactions between modifications? What is the impact to Users and also the scale of change required by the modification?
- 12465. The Panel agreed with the suggestions made and that a refresh of the approach to prioritisation was required.
- 12466. ML agreed that, although the criteria are clear in the code in terms of complexity, importance, and urgency it would a good idea for the Panel to have a wider look as to how the prioritisation process might be improved. ML proposed to discuss this at TCMF as the Panel agreed on the importance of seeking industry input.
- 12467. No changes were made to the Prioritisation Stack. The Prioritisation Stack can be found <a href="https://example.com/here">here</a>.
