#### 1. Inflight Modification Updates/Potential New Modifications

## CM095 – Implementing Connections Reform and CM096 – Application of Gate 2 Criteria to existing contracted background.

- 6736. ML talked through the updated timelines for CM095 and CM096 (shown on slides 3 and 4 of the <u>Panel slides</u>) giving rational for the changes of dates.
- 6737. GW raised a concern around the number of days given to complete the Workgroup Consultation bearing in mind the need to review and respond to the documents.

  Adding that many people will be on holiday.
- 6738. ML responded advising that Code Governance were as comfortable as they can be with the dates for the Workgroup Consultation.
- 6739. GW questioned if the implementation date of 1 January 2025 was a confirmed final date.
- 6740. DW responded advising this was the date that was agreed and had been discussed with the Authority.
- 6741. HE also voiced concerns about the timing for the Workgroup Consultation and the turnaround for responses, adding should the timings be reviewed as there is a lot of work to do.
- 6742. ML advised that by adding extra time to the Workgroup Consultation, time would be lost further down the process.
- 6743. RW had a concern that with 35 possible Consultation questions whether there would be enough time to have valid discussions and, if WACMs are raised, enough time for each Proposer to be heard.
- 6744. ML advised this was also a concern for Code Governance and assurances had been given that resource within the ESO would be on hand to support, but acknowledged this was a risk.
- 6745. DW gave assurance that the leadership team will do everything they can to support these proposals.
- 6746. HE questioned the response on the implementation date, asking for clarity.
- 6747. ML confirmed that the implementation date was agreed by ESO and the Authority.
- 6748. ML went on to share the timeline for CM096 advising on the planned dates for the Workgroup Consultation.
- 6749. RW questioned whether Ofgem were committed to the timeline.
- 6750. ML responded advising that the 13 December date for receiving the Final Modification Reports would be fine.
- 6751. NH added the Authority had been part of the discussions and were comfortable with the timeline, however there are still ongoing conversations.
