

NATIONAL ELECTRICITY TRANSMISSION SYSTEM SEVEN YEAR STATEMENT MAY 2010

It is produced pursuant to the System Operator Standard License Condition C11 ("Production of information about the national electricity transmission system") of the licence to participate in the transmission of electricity granted to NGET pursuant to Section 6 (1) (b) of the Electricity Act 1989 (as amended by the Utilities Act 2000 and the Energy Act 2004). National Grid Electricity Transmission plc is a member of the National Grid plc ("National Grid") group of companies (the "Group").

The form of this Statement has been approved by the Authority in accordance with Standard Condition C11 of the Transmission Licence.
