Grid Code Development Forum – 2 November 2017

GC0096 and GC0097

GC0096: Storage, Definition and Assignment of Technical Requirements for Storage Technologies:

- This Modification is at Workgroup stage
- The Workgroup are finalising the Workgroup Consultation – Consultation likely to be issued December 2017

GC0097:TERRE:

- This Modification is at Workgroup stage
- The Workgroup Report is currently due to be presented to the January 2018 Panel meeting.
- New timetable presented to the Grid Code Review Panel in October 2017 seeking to extend the timetable by two months, more information on the delay from the Central TERRE project to be provided ahead of this being granted

GC0098 and GC0099

GC0098: Using GB Grid Code data to construct the EU Common Grid Model in accordance with Regulation (EU) 2015/1222 (CACM) and Regulation (EU) 2016/1719 (FCA)

- The Panel Determination vote took place on the 20 September and the Panel agreed by majority that the modification better facilitates the Grid Code objectives and should no successful appeals be received will be implemented on the **8 November 2017**

GC0099: Establishing a common approach to interconnector scheduling consistent with the single intraday market coupling processes set out within Regulation (EU) 2015/1222 (CACM)

- The Workgroup Consultation closed on 30 October 2017
- Next Workgroup meeting to discuss responses, discuss potential alternatives and hold the Workgroup Vote ahead of submission of the Workgroup Report to the Panel in December

GC0100, GC0101 and GC0102

GC0100: EU Connection Codes GB Implementation – Mod 1

- This modification was raised at the May GCRP. This Modification was accepted and the Workgroup are due to Report back to the **November** GCRP meeting

GC0101 EU Connection Codes GB Implementation – Mod 2

- This modification was raised at the May GCRP. This Modification was accepted and the Workgroup are due to Report back to the **November** GCRP meeting

GC0102 EU Connection Codes GB Implementation – Mod 3

- This modification was raised at the June GCRP. This modification was granted a one month extension at the September Grid Code Panel meeting. The Workgroup Report for this modification is now due to be presented at the **December** Panel meeting

GC0103: Introduction of Harmonised Applicable Electrical Standards

- Raised as an urgent modification and discussed at Special Grid Code Panel meeting on 27 July 2017
- Mapping sessions to take place on 9 and 10 November 2017 to define the scope of the modification and timetable to be presented to the Grid Code Panel

GC0104 & GC0105

GC0104: EU Connection Codes GB Implementation – Demand Connection Code

- Raised as modification and discussed at Grid Code Panel meeting in August 2017
- The Grid Code Panel granted a two month extension to the timetable and this Workgroup is now due to submit their Report to the March 2018 Panel
- Next meeting to discuss this modification will be held on the December workgroup day

GC0105: System Incidents Reporting

- Panel agreed that this should be treated as a Self-Governance modification
- Comments by Panel by 3 November, legal text checks and then being issued to Code Administrator Consultation likely mid-late November

GC0106: Data exchange requirements in accordance with Regulation (EU) 2017/1485 (SOGL)

- Raised as modification and discussed at Grid Code Panel meeting in October 2017
- To be discussed at Workgroup day today
- Robust timetable to be developed with Workgroup as a collective at Workgroup meeting
